公司概况 Company Overview

北京燃气蓝天控股有限公司（“本公司”或“北京燃气蓝天”，连同其附属公司统称为“本集团”，港交所股份代号：6828.HK）为专注于天然气全产业链发展的综合天然气供销商及运营商。

2016年5月，北京控股有限公司（股票代码：0392.HK）的全资子公司北京市燃气集团有限责任公司（简称：北京燃气）入股北京燃气蓝天，并成为单一最大股东。2017年2月，公司由“蓝天威力控股有限公司”（简称：蓝天威力）更名为“北京燃气蓝天控股有限公司”。本集团将依托北京燃气丰富的行业资源及财务资源优势，采用创新和多样化的天然气整体解决方案，进一步加快沿海经济带及内陆气源地区产业布局，为推动天然气产业发展和生态环境改善做出积极贡献。

集团秉承“发展清洁能源，提升客户价值，共创美好蓝天”的企业使命，致力于天然气全产业链的分销及运营，同时凭借多元化气源及低成本的优势，不断开拓终端用气市场，持续推进以天然气为主的清洁能源综合利用。

集团以香港为总部，分别在北京和深圳设有运营中心和支持中心，天然气项目覆盖京津冀、山西、吉林、辽宁、山东、江苏、安徽、浙江、湖北、四川、贵州、海南等具高增长潜力的省份。

集团管理团队均为行业内经验丰富的专业人才，曾就职于多个大型燃气运营商，包括新奥能源、港华燃气、中石油及中石化等。集团联席主席郑明杰先生于企业并购及全球能源业务投资管理领域拥有多年经验，他同时担任新时代能源有限公司（0166.HK）之执行董事。集团联席主席支晓晔先生为北京控股副总裁，同时亦为北京燃气总经理，在管道燃气业务及企业管理方面累积多年经验。

Beijing Gas Blue Sky Holdings Co., Ltd. (“The Company” or “Beijing Gas Blue Sky”, together with its subsidiaries are collectively referred to as “the Group”, HKEX stock code: 6828.HK) is a comprehensive natural gas supplier and operator focused on the development of the whole natural gas industry chain.

In May 2016, Beijing Gas Group Company Limited (Beijing Gas), a wholly-owned subsidiary of Beijing Enterprises Holdings Limited (Beijing Enterprises, stock code: 392.HK), invested in the Company and became its single largest shareholder. In February 2017, the Company name was changed from “Blue Sky Power Holdings Limited” to “Beijing Gas Blue Sky Holdings Limited”. Leveraging upon rich industry and financial resources of Beijing Gas, the Company will work with Beijing Gas and adopt innovative and diversified natural gas solutions to further accelerate its business development along the coastal economic zones and in inland areas with abundant gas sources.

The Group adheres to its corporate mission of “develop clean energy; enhance customer value; create a bright future for blue sky”. The Group is committed to the distribution and operation

of the entire natural gas industry chain and will continue to develop in such industry by leveraging upon the availability of diversified and cost competitive gas resources.

Based in Hong Kong, and with key management offices in Beijing and Shenzhen, our natural gas business covers provinces with high growth potential, such as Jing-Jin-Ji, Shanxi, Jilin, Liaoning, Shandong, Jiangsu, Anhui, Zhejiang, Hubei, Sichuan, Guizhou, and Hainan, etc.

The Group’s senior management team has extensive industry knowledge and experience. They come from various background, including ENN, Towngas China, PetroChina and Sinopec. Mr. Cheng Ming Kit, Executive Director and Co-Chairman of the Group, has over 10 years of experience in M&A, capital markets and corporate finance in the energy sector. He also serves as Executive Director of New Times Energy Corporation Limited (0166.HK). Mr. Zhi Xiaoye, Non-Executive Director and Co-Chairman of the Group, is currently Vice President of Beijing Enterprises. He also serves as General Manager of Beijing Gas and has rich experience in pipeline gas business and enterprise management.

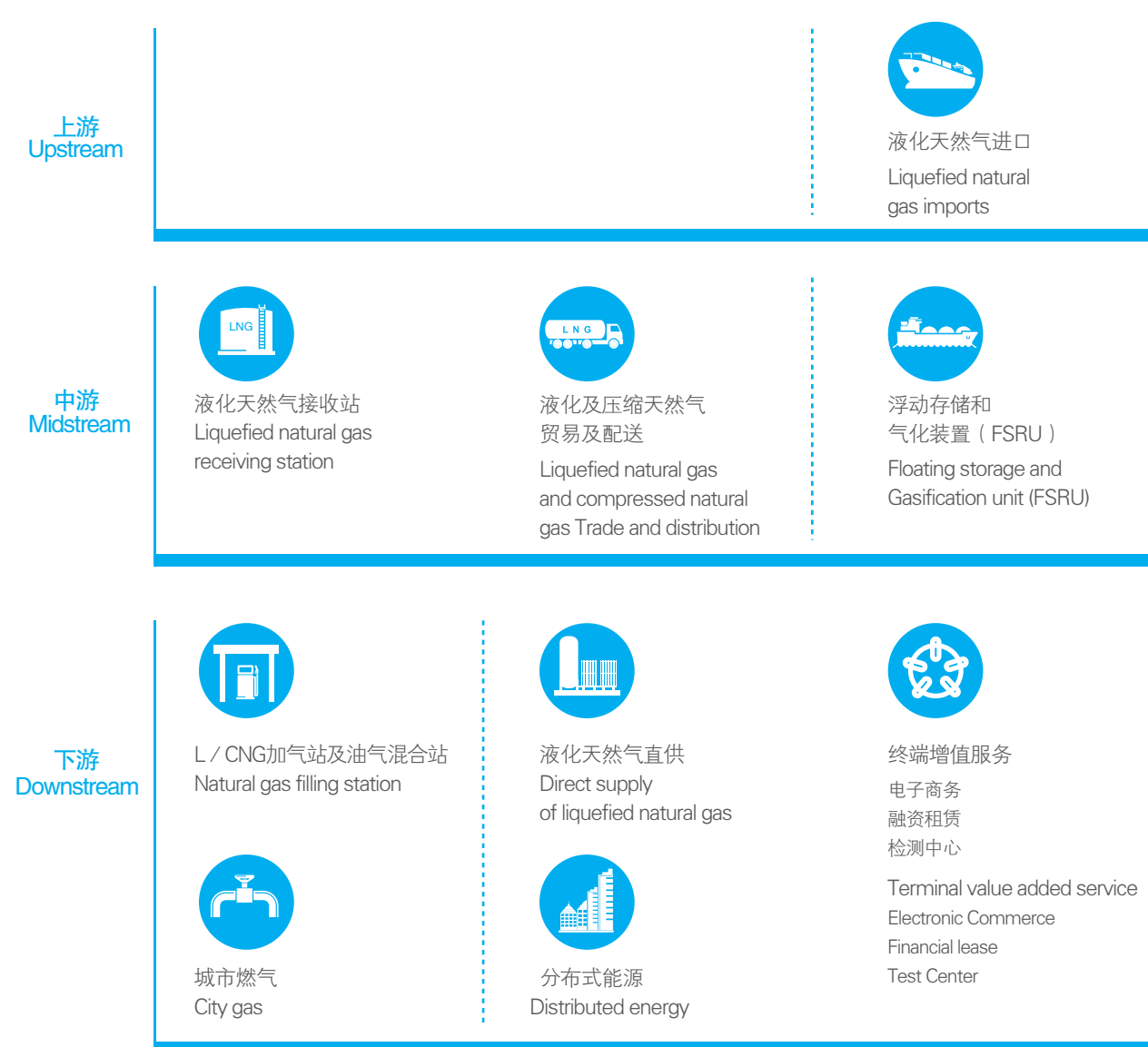

核心业务 Core Business



北京燃气蓝天主要从事的天然气业务包括：

- (1) 发展及经营城市燃气项目；
- (2) 直接供应液化天然气予终端用户，如工业用户；
- (3) 压缩天然气、液化天然气和液化石油气的贸易及配送；
- (4) 经营车用压缩天然气及液化天然气加气站。

自2016年以来，集团致力于投资扩大业务的地理布局至中国的十七个省份，其中包括通过不断壮大的L/CNG运输车队及终端用户网络布局而拥有较强L/CNG分销能力的沿海省份。

随着中国内陆地区基础设施的不断改善，以及中央政府推动清洁环境建设的力度加大而使得天然气的需求量快速增长，集团亦将持续从中寻求中国内陆的投资及合作机会。

BG Blue Sky' s core businesses encompass: (i) development and operation of city gas projects. (ii) direct supply of liquefied natural gas (LNG) to end-users, such as industrial users. (iii) distribution and trading of compressed natural gas (CNG), LNG and liquefied petroleum gas (LPG) .(iv) operation of CNG and LNG refueling stations for vehicles.

Since 2016, the Group has expanded its geographical investment and operation reach to cover more than seventeen provinces in China including all the coastal provinces where the Group has a strong distribution capability of L/CNG through its growing L/CNG transportation fleet and a growing distribution network to end-users.

The Group will further pursue inland investment and cooperation opportunities within China, where the demand for natural gas continues to increase as a result of the continuous improvement in inland infrastructure and the central government's efforts to promote a clean environment.

北燃蓝天的战略布局是于沿海“一带”，依托海气为主要气源，结合各地多元化的管网和液化厂的气源优势，扩展以工业点供气为主导，LNG/CNG加气站运营和LNG/CNG贸易及配送业务为业务组合。

于内陆地区方面，北燃蓝天的“一路”战略是选择气源富集区域、气价有合理价差和工商业发展有潜力的区域进行投资和经营城市燃气项目。

“一路”：内陆西部地区，气源丰富，价格低廉

“One Road”：From Shanxi all the way to the western and north-western provinces, which have rich gas resources

BG Blue Sky's "One Belt" strategy is to focus on the coastal areas with imported LNG as main gas sources. Relying on the strengths of pipeline networks and liquefaction plants, the main business focuses on industrial direct supply, with L/CNG refueling stations and trading as supporting businesses.

In the inland areas, BG Blue Sky's "One Road" strategy is to invest in city gas projects with abundant and cost competitive gas resources and high potential for industrial and commercial development.

天然气知识 Natural Gas Information

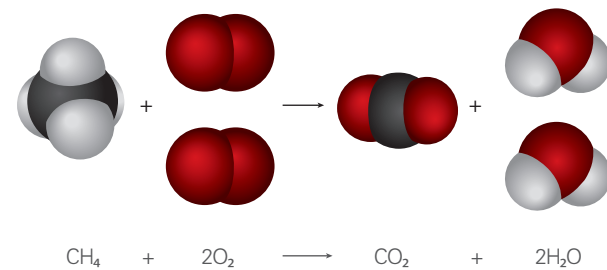
天然气的定义 Definition of Natural Gas

天然气是存在于地下岩层中的一种可燃气体，如气层气、油田气、煤层气等。其主要成分是甲烷，基本不含硫，是无色、无毒、无腐蚀性气体。

天然气的热值为8500 – 9500Kcal/Nm³；密度约0.75 – 0.8 Kg/Nm³，比空气轻，易逸散。

天然气的相对密度是指相同压力及温度条件下，天然气和空气密度之比，约为0.58–0.62。

天然气燃烧后只生成二氧化碳和水，产生的温室气体仅有煤炭的1/2、石油的2/3，对环境的污染远远小于石油和煤炭，是一种高效清洁的能源。



Natural gas is found in deep underground rock formations or associated with other hydrocarbon reservoirs in coal beds and as methane clathrates. Methane is the main component of natural gas. It does not contain sulfur, and is a colorless, non-toxic, and non-corrosive gas.

Natural gas has a calorific value of 8500–9500 kcal/Nm³, density of about 0.75–0.8 Kg/Nm³, which is lighter than air and easy to escape into the air.

The relative density of natural gas is the ratio between natural gas and air under the same pressure and temperature condition, and reaches about 0.58 – 0.62.

Natural gas produces carbon dioxide and water after combustion, and the greenhouse gas produced is only 1/2 of that from coal and 2/3 of that from oil. It is a highly efficient clean energy with less pollution than coal and oil.

天然气的形态 Forms of Natural Gas

天然气常见的应用形态有管道天然气、液化天然气（LNG）和压缩天然气（CNG）三种。

管道天然气：由气田开采后直接通过管道输送到客户端的天然气。

液化天然气（LNG）：天然气在常压下，冷却至约-162℃时，将由气态变为液态。

压缩天然气（CNG）：天然气经过加压至20Mpa，并以气态存储于压力容器中。

Application forms of natural gas normally include pipeline gas, LNG and CNG.

Pipeline natural gas: Natural gas transported directly to users via pipelines upon mining from the field.

Liquefied natural gas (LNG) : Natural gas changes from gas to liquid form upon cooling to about-162℃ under normal pressure.

Compressed natural gas (CNG) : Natural gas being pressurized to 20 Mpa and stored in a gaseous state in hard containers.

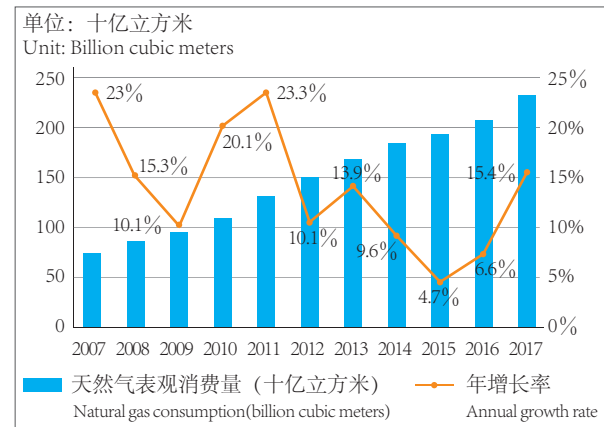

中国天然气表观消费量 (2007-2017)

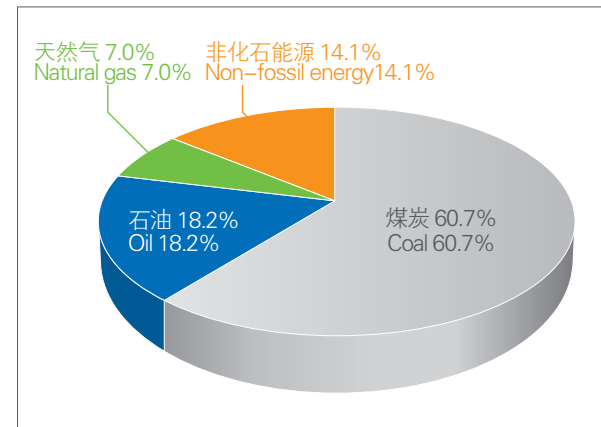
China's Natural Gas Consumption (2007-2017)

天然气的优势 Advantages of Natural Gas

安全: 天然气不含一氧化碳, 密度小于空气, 即便泄漏, 也会立即向上扩散, 不易积聚形成爆炸性气体, 也不易引发中毒事故。

高效: 天然气的热值高, 约为人工煤气的2.3倍, 因而比人工煤气耐用。

清洁: 天然气的杂质含量极少, 能减少二氧化硫和粉尘排放量近100%, 减少二氧化碳排放量60%和氮氧化物排放量50%, 目前天然气应用备受国家政策大力扶持。

Safe: Natural gas does not contain carbon monoxide, and its density is less than air. It immediately dissipates upwards if it leaks.

Efficient: The calorific value of natural gas is high, about 2.3 times that of artificial gas, and is more durable than artificial gas.

Clean: Natural gas has extremely small amount of impurities and can reduce (i) sulfur dioxide and dust emissions by nearly 100%, (ii) carbon dioxide emissions by 60% and (iii) nitrogen oxide emissions by 50%. Currently, there are numerous national policies to support natural gas applications.
